Robin M. Peguero, *Live Free and Nullify: Against Purging Capital Juries of Death Penalty Opponents*, 127 HARV. L. REV. 2092 (2014).

(Work Cited by the Attorneys of Dylan Roof in his Capital Pleadings)

Argument: "[P]urging nullifiers from juries is an American tradition," but it does not have to persist. The prospect of jury nullification as legitimate runs in particular tension with the Supreme Court's death-qualifying jurisprudence. This work argues that the for-cause removal of antideath jurors ought to be abolished.

Robin M. Peguero, Leading Case, <u>Sixth Amendment — Assistance of Counsel — Retroactivity —</u> Chaidez v. United States, 127 HARV. L. REV. 238 (2013).

Argument: In its close reading of *Padilla*, the *Chaidez* majority mistook mere argument by refutation as proof of *Padilla*'s novelty, relegating the discernment of retroactivity to a debate over argumentative style and inverting the ordinary incentives of Court opinion writers.

Argument: The examination of adequacy at the class certification stage offers a fresh and compelling avenue for judges to gauge the level of popular support that policing strategies draw in the communities that share in their burdens and benefits.
